Overview: This course will provide an overview of the main research questions and recent contributions in the economics of crime literature. The class covers a series of topics, including deterrence, incarceration, policing, undocumented migration, but also how social programs and social conditions (family structure, education, etc.) influence crime. Lectures will focus on econometric identification issues, data availability, as well as potential need of economic modelling.
