4. Introduction

The protection of your personal data is very important to us. With this privacy policy, we would like to inform you about how we process your data in the context of our online seminar, in particular in connection with the recording and publication of the seminar recordings on YouTube.

5. Purpose of data processing

We record the seminar in order to make it available to the public at a later date and to ensure that it is documented for posterity. The recording includes the talk and possibly questions and contributions from participants during the talk.

6. Types of data and processing of your data

The following data will be processed in the context of the seminar:

- Contact details provided during the registration process (name, institution, email). Only your email address is required for registration; all other information is voluntary. The software used for planning is Eveeno, the applicable data protection provisions of eveeno can be accessed at <https://eveeno.com/de/privacy>.
- Metadata for conducting the online seminar. Microsoft Teams will be used to conduct the seminar. Data will not be processed outside the European Union (EU) as we have restricted our storage location to data centers in the European Union. However, we cannot completely rule out the possibility that data may be routed via Internet servers located outside the EU. This may be the case in particular if participants in the online meeting are located in a third country.
- Video data (including images and audio of the presenter and, if applicable, participants who consent to the recording)
- Transcription of the video data
- Data expressed in connection with participation in the chat or verbally during the seminar

7. Legal basis for processing

Your data is processed on the basis of your consent in accordance with Art. 6 (1) (a) GDPR. You can revoke your consent at any time, but this does not affect the lawfulness of the processing until revocation.

8. Your rights

Right to information: You can request information in accordance with Article 15 GDPR about your personal data that we process.

Right to object: you have the right to object at any time, on grounds relating to your particular situation, to the processing of your personal data carried out on the basis of Article 6(1)(f) GDPR. The controller shall then no longer process the personal data unless it can demonstrate compelling legitimate grounds for the processing which override the interests, rights and freedoms of the data subject.

Right to rectification: If the information concerning you is not (or is no longer) accurate, you can request a rectification in accordance with Art. 16 GDPR. If your data is incomplete, you can request that it be completed.

Right to erasure: You can demand the erasure of your personal data in accordance with Art. 17 GDPR.

Right to restriction of processing: You have the right to request restriction of the processing of your personal data in accordance with Art. 18 GDPR.

Right to complain: If you believe that the processing of your personal data violates data protection law, you have the right to lodge a complaint with a data protection supervisory authority of your choice in accordance with Art. 77(1) GDPR. See A. 3. of this privacy policy.

Right to data portability: If the requirements of Art. 20 (1) GDPR are met, you have the right to have data that we process automatically based on your consent or in fulfilment of a contract handed over to you or to third parties.

9. Duration of storage

The records will be stored for as long as necessary for the purposes stated or for as long as statutory retention periods apply.

10. Disclosure to third parties

The video recordings will be published on our YouTube channel. Your personal data will only be disclosed to third parties in connection with the publication.

11. Right of withdrawal and contact

You may withdraw your consent to recording and publication at any time. In this case, the corresponding recordings will be deleted, provided that there are no legal obligations to the contrary.
